Product Overview

Upgrading from earlier Micro Focus products



Note: Windows-only.

This version of your product is dependent on a later version of the Microsoft C run-time system than earlier Micro Focus products. This means that COBOL executables (.exe) built with a version earlier than 4.0 might not be compatible with the current version of the run-time products. If the behavior of your application changes with the current version, we strongly recommend that you relink the main executable with the current version. This will ensure that the COBOL run-time system fully handles any run-time error conditions that might occur.

A new executable that is fully compatible with the current version can be produced without recompiling the application, as long as the original object code is available and it is relinked with the current version.

To allow your executables to benefit from the product's latest programming and performance enhancements, we recommend a full recompilation of your source code.

If you are using Eclipse, Enterprise Developer can automatically relink existing projects created with Enterprise Developer earlier than 4.0 that have executable link artefacts. Eclipse displays a warning in the Problems view that the project requires relinking. It then offers a Quick Fix action for you to execute that will link your project with the most recent version of the Run-Time System.

What's New

- **Micro Focus Enterprise Developer** which provides a contemporary development suite for developing and maintaining mainframe applications, whether the target deployment is on or off the mainframe.
- Micro Focus Enterprise Test Server which provides a comprehensive test platform that takes
 advantage of low cost processing power on Windows environments, to supply scalable capacity for
 testing z/OS applications without consuming z/OS resources.
- Micro Focus Enterprise Server which provides the execution environment to deploy fit-for-purpose
 mainframe workload on Linux, UNIX and Windows (LUW) environments on IBM LinuxONE (IFLs),
 standalone servers, virtual servers, or the Cloud.
- **Micro Focus Enterprise Server for .NET** which provides the execution and modernization platform to deploy fit-for-purpose mainframe workload on a scale-out .NET infrastructure and the Azure Cloud.



The Micro Focus Enterprise extension for Visual Studio Code provides the following enhancements:

 The use of the Micro Focus Enterprise extension with Enterprise Developer 8.0 provides PL/I editor, compiler and debug support. The PL/I debug support includes data breakpoints, conditions, and signals.

This release offers the following improvements:

- A new "Select Element List" button in the action bar of the Table Results view enables you to directly select an existing list. Navigation in the history using the backward and forward arrows is now per Eclipse session.
- A new relationship for an action, Create Element List.
- A new JES function package enables you to define tools in an AWM model to browse, cancel, or delete z/OS jobs.
- The IDz Function Package Tools now support the new tool interface introduced with release 5.0.
- A new Filter Data Tool in the AWM function package.

This release introduces the following new features in Eclipse:

- A CICS Resources context menu command for CICS-enabled native enterprise server regions in Server Explorer - enables you to manage the PCT, FCT, and PPT resources.
- Enterprise Server validation in the IDE for CICS Web Services.
 - Reports validation errors where the associated enterprise server region configuration requires adjustments to support the CICS Web service.
 - Enables you to change the current configuration of the enterprise server region.
 - Validates that the enterprise server region supports the CICS Web service when all validation errors are resolved.

COBOL Language

The following enhancements have been made to the Micro Focus COBOL language:

- Further support for IBM Enterprise COBOL 6.3:
 - JSON PARSE and JSON GENERATE statements for JSON GENERATE, anonymous objects can be generated using the OMITTED key word; the SUPPRESS phrase has been enhanced; the CONVERTING phrase is supported. For JSON PARSE, anonymous objects can be parsed using the OMITTED key word; the CONVERTING phrase is supported.
 - Intrinsic functions the following list of functions is now supported: COMBINED-DATETIME, FORMATTED-CURRENT-DATE, FORMATTED-DATE, FORMATTED-DATETIME, FORMATTED-TIME, INTEGER-OF-FORMATTED-DATE, SECONDS-PAST-MIDNIGHT, SECONDS-FROM-FORMATTED-DATE, TEST-FORMATTED-DATETIME, and UUID4.
 - The AMODE Compiler directive has been enhanced to allow COBOL programs full access to the 64bit address space (AMODE"64"). This emulates the LP"64" option in Enterprise COBOL.
 - The DYNAMIC LENGTH clause, introduced in the last product release, is now supported in JVM COBOL (as well native COBOL).

- JVM COBOL enhancements:
 - When no explicit type is declared for a variable, but the value is a non-integer numeric (for example declare var1 = 1.23), it is assumed to be of type float-long.
 - The NAME OF expression has been introduced. It returns the unqualified name of the type or member specified.

Code Analysis

The Application Analysis Server enables you to access either Micro Focus Enterprise Analyzer or COBOL Analyzer from the IDE. This release includes the following enhancements to this feature:

- A generate code search report and a single code search reports are available.
- An improved Get Direct References report.

Enhancements to the Analysis Services include:

- An enhanced Program Flow Graph
- Support for displaying the Data Flow analysis as a Graph.
- A new Eclipse preference page, Application Wide Knowledge in Window > Preferences > Micro
 Focus > COBOL > Code Analysis. This enables you to adjust certain timeout settings for certain longrunning queries executed against a remote Enterprise Analyzer or COBOL Analyzer server.

Enhancements in the Rule-Based analysis include:

The Rules preference page in Window > Preferences > Micro Focus > COBOL > Code Analysis
now supports nested rules.

DISPLAY-PICU - defines the way PIC U data items are displayed: either as ANSI or UTF-8.

The following Compiler directive has been enhanced in this release:

 AMODE - a new parameter "64" stores pointers in 64-bit format - see COBOL Language Enhancements for more details.

Enterprise Server debug configurations can now configure the **Program breakpoint on main entry** point only option, which if selected, only breaks execution when the Procedure Division entry point is called.

Enhancements are available in the following areas:

Product:

- Enterprise Developer for Eclipse is now available on Linux platforms. Includes features such as:
 - Building and debugging of mainframe COBOL projects
 - Support for PL/I background parse, running and debugging
 - CICS Web services
 - Server Explorer
 - IMS support for PSB, DBD, and MFS Files
 - · Data File Editor
 - Code analysis using the Application Analysis server
- This release supports Eclipse 4.20 (2021-06), which is shipped and installed with Enterprise Developer. Versions of Eclipse prior to this one are not supported.

Projects:

- Apache Maven support native COBOL and native COBOL Unit Testing projects can be incorporated into your Maven-based lifecycles. They now accept a pom.xml file, which can be configured to run the Maven AntRun plugin, which allows Ant-based projects to work with Maven.
- Automatic directives determination it is now possible to specify if this should run and if you will be prompted to perform it from **Perform automatic directives determination** preference, available from Window > Preferences > Micro Focus > COBOL|PL/I > Directives Determination.
- Code Clean Up you can configure code clean up preferences, which you can apply to your code to ensure consistency throughout your COBOL code (for example consistent use of the PIC or PICTURE keyword). These preferences are stored in profiles, which allows them to be shared among development teams.
- Multi-file compilation right-click a selection of files, and click Compile when Automatic Build is disabled. This utilizes the Maximum compilations/links to execute concurrently option (available from Window > Preferences > Micro Focus > Builder > Project) for native COBOL projects.
- Order of the Dependency Paths list it is now possible to control the initial position of the new directory in the list. Use the Insert to the beginning of dependency paths list or Append to the end of dependency paths list options to determine the position. These options are available from Window > **Preferences > Micro Focus > Builder > Project.**

COBOL Editor:

- COBOL code mining code minings are additional content shown in the COBOL editor to give extra context to certain code elements. Use the Window > Preferences > Micro Focus > COBOL > Editor > Code Minings page to enable an indicator showing the number of times that a section or a paragraph is called in your native or procedural JVM COBOL code. Select the link shown to show a list of references in the Search view, where you can use the matches shown to jump to the actual call within your code.
- end- delimiter tooltips within the COBOL editor, if you hover over the end- delimiter of a statement such as an IF or an EVALUATE statement, a tooltip showing the opening clause of the statement is displayed. You can enable/disable this behavior from the Block matching section in the COBOL editor preferences.

Enhanced BMS tools integration with Eclipse on Windows and Linux:

- A **BMS Preview** view inside Eclipse enables you to preview the BMS screens on Windows and now on Linux where the standalone Micro Focus BMS Painter utility is not supported.
 - To invoke the preview, open a BMS file in the editor and click **Toggle the BMS previewer view** in the Eclipse toolbar.
- The BMS text editor in Eclipse now offers enhanced writing support with smart editing and smart tabs, smart Home/End caret support, collapsible sections in the BMS code, and initial syntax checking and error reporting on background parse.
- The tree structure inside the **Outline** and **Program Outline** views now includes the mapsets and maps, and any macro attributes and strings. Hovering an element in the views shows their properties.

Enterprise Server

Back to Top

This release provides enhancements in the following areas:

- EZ Sockets now supports up to 4096 sockets on Linux, up from 1024, and enhanced tracing.
 - EZ Sockets applications, including ones that use the CICS listener CSKL (EZACIC02), can have more simultaneous connections.
 - EZ Sockets tracing now has options for logging the recent history only when any error or one of a set of particular errors occurs. This makes it easier to use tracing to diagnose EZ Sockets issues.
- Enterprise Server dataset management dataset maximum retention period with the ability to alter and create reports:
 - ES_JES_ENFORCE_EXPIRE_DATE helps determine whether or not to check the expiration date when deleting a catalogued dataset, and if expired, delete the dataset. If it hasn't expired and the PURGE option has not been specified, the dataset is not removed. The PURGE keyword is required to delete non-expired datasets. PURGE removes the underlying physical dataset file unless it is referenced by another catalog entry. SMS MANAGEMENTCLASS now supports maximum RETAIN days. See *Using SMS MGMT Classes* and the %SMS example command in the same topic.
 - ES_JES_LISTCAT_YMD helps determine the date format used in the HISTORY report generated when the IDCAMS LISTCAT command specifies the ALL option.
 - The EXPDT entry in a DD statement must be a four-digit year (YYYY); otherwise 1900 is the default, which is in-line with the mainframe processing, and prevents unexpired datasets from being erroneously removed (as was the case with the previous default of 2000). The ALTER command now takes the TO and FOR options to enable specification of the retention period for the entry being altered. The maximum retention period might be limited by the management class. The IDCAMS LISTCAT command ALL parameter now generates a separate HISTORY report that shows the creation date time and job, the last changed date time and Job, and the expiration date.
- HTTP compression the Communications Server supports compressing large HTTP responses with gzip, and handles gzip-compressed HTTP requests. The Common Client supports gzip-compressed HTTP responses. Some large HTTP responses are compressed automatically if the client supports it.
 Large HTTP messages can be compressed, saving network bandwidth and improving performance.
- Task-cleanup performance the performance of post-processing for tasks in MFCS has been improved.
- ICETOOL emulation now supports the COUNT+*n* and COUNT-*n* syntax during trailer processing, where *n* is a numeric between 0-999. This adds to or subtracts from the COUNT value.
- DSNRLI now implements one-phase commit optimization where appropriate.
- Listing DEQ errors a new caspac action, CasDEQs, enables you to list all errors that might have occurred on DEQs either at the end of a task or while a job or a transaction was executing.

- Enterprise Server configuration you can now change the recording directory of the dump, trace, HSF, and the console.log files of each region. See Alternative Enterprise Server Output Locations for more information.
- CICS API support the CICS API GET CONTAINER option BYTEOFFSET is now supported.
- Compression on ECI calls via CASBNCCL Client when using the Micro Focus External Call Interface (ECI) over TCP/IP, the request and response data flows are now compressed using RLE.

Enterprise Server Common Web Administration (ESCWA)

Back to Top

This release includes the following enhancements:

- Oracle Coherence is now available as a PAC Scale-Out repository as an alternative to Redis.
- Reduced number of Redis instances required when a PAC incompatible upgrade is performed it is now possible to have multiple PSORs in one REDIS instance. This allows for the REDIS instances provisioned in the PAC to be reused.
- Enhanced PAC diagnostics via CTF a new option on the ES Control page is now available to enable or disable CTF for a running region without the need to recycle the region.
- ESCWA API, version 2 includes updated versions of some of the existing API, version 1 endpoints, with improved JSON property names, more sensible URIs. The version 2 API is a single API standard across API endpoints. It includes a number of usability enhancements, has a better readability and discoverability, and includes an improved API documentation.
- **Enterprise Server Configuration Manager**
 - A variety of configuration options are available in ESCWA on the General >Advanced page for a region.
 - The property grid in ESCWA shows the full list of configurable properties, categorized by group, along with help text and some additional meta-information. Properties marked as dynamic in the property grid can also be updated in a running region.
 - A number of properties that were previously set with environment variables are now available in the ESCWA UI. The environment variables are still supported for backward compatibility.
- Accessibility enhancements the ESCWA UI includes a number of improvements in the areas of usability with screenreaders, color contrast, and text and icon sizing and alignment. This is to give it an improved compliance with the 508 and WCAG 2.1 standards.

Enterprise Server Security

Back to Top

This release includes the following enhancements:

- AWS Secrets Manager support is available for using an AWS Secrets Manager, mfsecretsaws, as a remote vault. See The mfsecretsaws Vault Provider.
- Protection for sensitive data some sensitive data is now protected in the memory. This helps reduce the risk of exposing sensitive data such as passwords in core dumps and similar scenarios.
- An option to update short names the ESF Update mechanism enables you to change between OS users ("long names") and ES userids ("short names") in running regions. This requires a non-default configuration setting.
- Caching improvements ESF caching now caches more types of requests. This helps improve the Enterprise Server latency and throughput when external security is configured with caching.
- Support for Argon2 in password history when Micro Focus passwords are used with the MLDAP ESM Module and password history is enabled, use Argon2 password verifiers in the history to avoid the potential exposure of passwords via weaker verifiers. This helps improve the security of the passwordhistory mechanism.

The product Help includes a new section, Securing Enterprise Server, which provides guidance on improving the security of Enterprise Server installations and the applications they host. This includes information on security and how to reduce security exposure.

JCL Support

Back to Top

This release provides the following enhancements:

- In Eclipse, a Show Spool and a Show Catalog context-menu command are available in Server Explorer for MSS-enabled enterprise servers. These enable you to display and manage the regions' JES spool gueues and catalogs, respectively.
- Support is available for the DSENQSHR JOB statement parameter with options of ALLOW, USEJC, and DISALLOW. You can configure the use of this parameter with the new ES DSENQSHR environment variable for Enterprise Server.

Mainframe Access

This release introduces:

- UNIX client support (EAP) a subset of the MFDAS command-line functionality is now supported on UNIX. Features include:
 - Download, upload, and administration of data sets and JES.
 - Client post-processing such as DFCONV conversion.
 - UNIX Vault storage for user credentials

- PostgreSQL and Microsoft SQL Server now support storing datastores, region databases, and crossregion databases in a single physical database, instead of storing them in separate databases.
- Configurations that use a single physical database can now use a single database connection to access all MFDBFH resources stored within.

You can now use the Micro Focus Unit Testing Framework to build and run test cases from within a .NET 6 environment. Install the NuGet package supplied with Enterprise Developer to enable the mfunit extensions to the dotnet command line utility.

- Various actions and operations within your COBOL development environment depend on certain Microsoft files distributed in the following packages: the Windows SDK package and the Microsoft Build Tools package. If you do not plan to use your development tool in a way that will depend on any of these packages, you can run a non-standard installation, which will skip their download and installation, thus saving disk space and time taken for installation. Required environment variables

where java_install_dir is the path to the JAVA installation directory such as /usr/java/javan.n

• Add \$JAVA HOME/bin to your system PATH variable. To do this, execute:

```
export PATH=$JAVA HOME/bin:$PATH
```

You need to set the LANG environment variable to pick up localized messages. If you do not set it as specified here, the installation will run but you might experience unexpected behavior from the installer.

The LANG settings are English and Japanese only so set it to one of the following locales:

```
C, default, en_GB, en_GB.UTF-8, en_US, en_US.UTF-8

You can set LANG before running the setup file as follows:

export LANG=C

Issues with the Installation on UNIX and Linux

Installing on Linux

On Linux, the RPM installer for Enterprise Developer for Eclipse installs a 64-bit version of Java. When you start the installation, if the 32-bit version of Java is already installed on your Linux machine, you might not be able to install Enterprise Developer. This is a *known issue* with the Oracle Java installers for Linux which prevents you from installing both the 32-bit and the 64-bit versions of Java on the same machine. To work around this problem:

- Download the 64-bit Java distribution in a compressed .tar format from the Oracle Web site.
- Untar the distribution into a location different from the one used for the 32-bit Java version. For example, untar in /usr/local/java64 and not in /usr/local/java.
- Set JAVA_HOME and LD_LIBRARY_PATH to the 64-bit version of Java so that it is used to install and run Enterprise Developer.

Installing on Red Hat 8.x s390

On Red Hat 8.x s390, the RPM non-root install method is not supported due to errors given by cpio. You receive the following messages:

```
error: unpacking of archive failed on file /usr/lib/.build-id/lb/
af99f26c6b4c00ca499a3199a574b73aeb3854;6092b79c: cpio: symlink failed - No
such file or directory
error: Micro_Focus_cobol_server-7.0.0.0-100700.s390x: install failed
```

As a result, the installation in this scenario is incomplete.

Installing while using AFS/Kerberos authentication

If you are using AFS/Kerberos authentication to log onto your Linux system then you need to ensure you have a local user ID which SOA and Enterprise Developer components of the product can use. This user ID must be set up prior to running the installer. When running the installer you need to specify -ESadminID=[User ID] on the command line so it is used by the installer.

License Server

You need to configure the computer hostname to ensure the license server will start properly.

To avoid performance issues, "localhost" and the computer hostname must not both be mapped to IP address 127.0.0.1. You should only map "localhost" to IP address 127.0.0.1.

The following is an example of how to specify these entries correctly in the /etc/hosts file:

127.0.0.1 localhost. localdomain localhost IP machinelonghostname machineshorthostname

where IP is the unique IP address of the computer in xx.xx.xx format.

Basic Installation

The instructions in this section apply when you are performing a basic installation of this product for the first time. If you are an administrator, you can perform a basic installation on a local machine before performing a more advanced installation when rolling out the product to developers within your organization.

Installing on Windows



- This version of the product is a full install.
- If you have an earlier version of Enterprise Developer installed on your machine, check Installing as an Upgrade before you start the installation - see Advanced Installation Tasks.

These are the steps to install Enterprise Developer:

1. Run the ede 80.exe file and follow the wizard instructions to complete the installation.

By default, this installs Enterprise Developer in the %ProgramFiles(x86)%\Micro Focus \Enterprise Developer folder and installs a full version of Eclipse 4.20 (2021-06) 64-bit, with the Micro Focus plugins already installed, in the C:\Users\Public\Micro Focus\Product Name \eclipse directory.

The setup file installs any missing prerequisite software as listed in the topic Software Requirements.



Note: See Advanced Installation Tasks for information about non-default installation tasks.

Installing Micro Focus Enterprise Developer UNIX Components

Micro Focus offers two types of installers on UNIX and Linux - a proprietary Micro Focus installer for installing on UNIX and Linux and a standard RPM (RPM Package Manager) installer for installing on Linux. See your product Help for instructions on how to use the RPM installer.

Before starting the installation, see *Software Requirements*.

These are the steps to install this product using the Micro Focus installer:

1. Give execute permissions to the setup file:

```
chmod +x setup_entdev_8.0_platform
```

2. Run the installer from the Process User ID login:

```
./setup_entdev_8.0_platform
```

When the installer starts it will prompt you to enter the superuser password so it can perform operations that require root permissions.



Note: On Ubuntu, the prompt for superuser password is not available. On this platform you must either log in as root or use the sudo command to get root permissions before you run the installer.

The COBOL environment is installed by default into /opt/microfocus/EnterpriseDeveloper. (COBDIR).

Enterprise Server System Administrator Process

During the installation process, the installer configures the product's Enterprise Server System Administrator Process User ID. The Process User ID will be the owner of all Enterprise Server processes except the one for the Micro Focus Directory Server (MFDS). The Directory Server process (Enterprise Server Administration) runs as root as this allows it to access the system files and ports.

All Enterprise Server processes you start from Enterprise Server Administration run under the Process User ID which can affects the file access and creation.

You must supply the user ID at the command line - specify -EsadminID=[ID] as part of your command.

By default, the installer uses the login id of the user that runs the installer for the Process User ID. To change the user id after you complete the installation, execute \$COBDIR/bin/casperm.sh and follow the onscreen instructions.

SafeNet Sentinel considerations

The installation of this product could affect the SafeNet Sentinel licensed components running on your machine. During installation licensing is shutdown to allow files to be updated. To ensure the processes running on your machine are not affected, you need to use the -skipsafenet option, which skips the installation of SafeNet:

```
./setup_entdev_8.0_platform -skipsafenet
```

To protect the SafeNet Sentinel installation from accidental updating you can create an empty file named SKIP_SAFENET_INSTALL in /var/microfocuslicensing/ as follows:

```
touch /var/microfocuslicensing/SKIP SAFENET INSTALL
```

While the file is present, the SafeNet installer does not make changes to the installation or shutdown the running license daemons. If licensing needs to be updated later, you can rerun the MFLicenseServerInstall.sh from within the \$COBDIR/safenet folder with the force command line option:

```
cd $COBDIR/safenet
./MFLicenseServerInstall.sh force
```

AutoPass Licensing considerations

The installation of this product could affect the AutoPass licensed components running on your machine. During installation, the licensing shuts down to allow files to be updated. To ensure the processes running on your machine are not affected, you need to use the -skipautopass option, which skips the installation of AutoPass:

```
./setup file -skipautopass
```

To protect the AutoPass installation from accidental updating, you can create an empty file named SKIP_AUTOPASS_INSTALL in /opt/microfocus/licensing as follows:

touch /opt/microfocus/licensing/SKIP_AUTOPASS_INSTALL

While the file is present, the AutoPass installer does not make changes to the installation or shutdown the running license daemons. If licensing needs to be updated later, you can rerun the MFLicenseServerInstall.sh from within the \$COBDIR/safenet folder with the force command line option:

cd \$COBDIR/safenet ./MFLicenseServerInstall.sh force

Installing as an Upgrade

Installing this release as an upgrade will automatically uninstall any Patch Updates of the older version of the product you have installed on your machine.

- This release can be installed as an upgrade to Enterprise Developer 7.0.
- If you have been using the mainframe components of Enterprise Developer for z Systems, see Installing z/Server as an Upgrade for recommendations about how to upgrade your z/Server installation. Also, check Backward Compatibility of AWM Models for information about changes that affect your existing AWM models.
- Before installing this release as an upgrade, ensure you create a back-up of your Enterprise Server configuration. To do this, on the Enterprise Server Administration home page, click **Export** and then select Export Enterprise Server configuration and Security Manager definitions. This creates a backup folder in the c:\programdata\micro focus\Enterprise Developer\MFDS. You can restore the Enterprise Server configuration after installing this release - click Import on the Enterprise Server Administration home page.

Directory considerations

- You must have read and write access for every directory accessed during the installation.
- You can override the default installation folder using the InstallFolder parameter.
- Installing creates a group of log files prefixed Micro_Focus_ in the %temp% folder, by default. To change the location or name, use the /log parameter on your Setup command line and specify the path and file name, for example:

/log drive:\path\LogFilename

Skipping installation of the Microsoft package dependencies

A standard installation downloads and installs the latest versions of the Microsoft Build Tools (for Visual Studio 2017) and the Windows 10 SDK packages to their default locations. Using the following option, you can skip installation of these packages, thus reducing the footprint and duration of the installation. See Microsoft Package Dependencies to see if you can safely skip installing these packages.

ede_80.exe skipmstools=1

Offline installations

An offline installation is one where the client running an install is not connected to the internet; the problem this presents is that the installer cannot download and install certain file and package dependencies; see Microsoft Package Dependencies. In such circumstances, an administrator (or at least someone connected to the internet) must download and make any dependencies available on the local network beforehand.

To prepare an offline installation, the administrator should run their own (online) installation using the downloadmstools parameter: this downloads the package dependencies to < directory>, which should be a fully-qualified path to a location accessible to the client when they run an installation.

start /wait ede_80.exe /q downloadmstools=<directory>

A client can then run an offline installation by pointing their installer at the location of the packages:

ede_80.exe installmstools=<directory>

This command runs a full product install; during which it uses the locally-accessible *directory* to install the package dependencies.

Installing silently

You can install Micro Focus products silently by specifying /q at the command line and using command line parameters to specify the installation directory (installfolder=path), user information, and which features to install. You must execute the command with superuser permissions.

start /wait install-file.exe /q [parameters]

Examples

To silently install Enterprise Developer into a directory other than the default:

start /wait ede_80.exe /q InstallFolder=c:\DirectoryName

- If you want to silently install the Eclipse IDE in a location other than the default, execute: start /wait ede_80.exe /q InstallFolder2=c:\EclipseInstallDirectory
- To silently install Rumba+ Desktop during the silent install of Enterprise Developer: start /wait ede_80.exe /q RumbaCheckbox=1

Microsoft Package Dependencies

Various actions and operations within your COBOL development environment depend on certain files that Microsoft distributes in the following packages: the Windows SDK package and the Microsoft Build Tools package.

There is a dependency on the Microsoft Windows SDK if you:

- Produce COBOL .exe or .dll files.
- Call Windows APIs from your COBOL .exe or .dll files.
- Link a C object file into a COBOL .exe or .dll file.
- Call Windows APIs from a C object file linked into a COBOL .exe or .dll file.
- Create MIDL files for OLE RPC.

There is a dependency on the Microsoft Build Tools if you:

- Produce COBOL .exe or .dll files.
- Manage .lib files.
- Convert resource files to object modules.

If you distribute a COBOL product installation to clients that do not have access to the internet, then you need to have downloaded these packages and placed them in an accessible place on the network before clients can run an 'offline installation'. The installer includes options to achieve this: downloadmstools enables you to download the required packages to a specific location; and installmstools enables an offline client to install the packages from a local network location.

If you do not use any of the features described above, you can use an install parameter (skipmstools=1) that will skip the download and installation of these dependencies.

All of these installation options are discussed in more detail in the *Installation Options* topic for your product.

One of the final steps of the installation process configures the downloaded and installed package versions for use in your COBOL environment. You can view these versions using the Microsoft Build Tools and Windows SDK Configuration Utility - see Managing the Microsoft Build Tools and Windows SDK Packages. This utility also enables you to specify alternative versions should you need to depend on a specific package other than the one downloaded, or one stored in a non-default location.

Installing and Licensing Micro Focus Rumba+ Desktop

The Enterprise Developer setup file includes Micro Focus Rumba+ Desktop 10.1 which you can install as an optional component. The license for Enterprise Developer also licenses all components of Rumba+ Desktop (for example, Rumba+ Desktop Office, Rumba+ Desktop for Mainframe, UNIX, AS400, and the TN3270 mainframe display within Enterprise Developer).



Note: Micro Focus Rumba+ Desktop versions 10.1 provide integration with Enterprise Developer where you can use a Rumba+ Desktop TN3270 Mainframe Display within the IDE in order to run applications.

Installation considerations:

If you are installing Enterprise Developer onto a machine that does not have Rumba+ Desktop installed, it is recommended that you select the Rumba+ Desktop option when you start the installation. This installs all of the components of Rumba+ Desktop including the one you need to establish a mainframe 3270 connection (Rumba+ Desktop for Mainframe).

Installing Rumba+ Desktop as part of this release of Enterprise Developer will update any older version of Rumba+ Desktop installed and licensed on your machine.



Note: Micro Focus recommends that you upgrade older versions of Rumba+ Desktop to the one installed with Enterprise Developer. However, if you want to keep an older version of Rumba+ Desktop, you can choose not to install Rumba+ Desktop when you start the Enterprise Developer installation.

If a version of Rumba+ Desktop more recent than version 10.1 is installed and licensed on your machine, you can choose not to install Rumba+ Desktop as part of the Enterprise Developer installation.

On UNIX

Installing as an Upgrade

This release works concurrently with the previous version of Micro Focus Enterprise Developer UNIX Components, so you do not need to uninstall it.

Install the latest version in a different location and set the environment to point to it. To do this, run the Micro Focus Enterprise Developer UNIX Components installer with the -installlocation option:

1. Execute the following command:

./InstallFile -installlocation="/opt/microfocus/EnterpriseDeveloper"



Note: You can use variables when specifying an absolute path for -installlocation. For example, the following examples are equivalent:

-installlocation="/home/myid/installdir"

-installlocation="\$HOME/installdir"

2. Execute cobsetenv to set the environment and point to the new install location:

. cobsetenv



Note: cobsetenv is only compatible with POSIX-like shells, such as bash, ksh, or XPG4 sh. It is not compatible with C-shell or pre-XPG4 Bourne shell.

Preserving the MFDS and Enterprise Server region configuration

The following information applies when you are upgrading from releases 6.0 or 7.0.

If you install this release to the same install location as release 6.0 or 7.0, the product in the current location is moved to a backup directory name.

For example, if the 7.0 product is installed in the default install location, /opt/microfocus/ EnterpriseDeveloper, during the upgrade it is moved to /opt/microfocus/ EnterpriseDeveloper.BKP.YYYY-MM-DD.HH:MM:SS. The new release will be installed in /opt/ microfocus/EnterpriseDeveloper.

Note that your original installation might include some files that you changed or added to, and you need those changes preserved in the new installation.

During the upgrade, the installer moves a number of changed files to a different configuration location and symbolically links them back into the new release install location. The configuration location is one of the following:

- The default config location is /opt/microfocus/config/.
- For non-root installation, the default location is \$HOME/microfocus/config/.
- To specify your own configuration location, run the setup file with the following command-line option: mfconfiglocation=[location]

The setup file creates a directory in the configuration location using the sum of the value of the \$COBDIR path. This is so that each configuration area is unique to each product installation. The configuration files

and directories are then placed in this COBDIR hash-numbered directory. In the examples below, the install location generates a hash of 12345.

The file /opt/microfocus/config/12345/COBDIRlocation.txt details the COBDIR the configuration area is associated with.

Currently, the setup file only moves the following files and directories:

Source	Destination
secrets	/opt/microfocus/config/12345/secrets/
commonwebadmin.json	<pre>/opt/microfocus/config/12345/escwa/ commonwebadmin.json</pre>
mfdsacfg.xml	<pre>/opt/microfocus/config/12345/mfds/ mfdsacfg.xml</pre>
mfds	<pre>/opt/microfocus/config/12345/mfds/ mfds/</pre>

If you have changed any other files in the original installation, you need to be copy these manually from the backup directory, /opt/microfocus/EnterpriseDeveloper.BKP.YYYY-MM-DD.HH:MM:SS, into the install location after the upgrade installation is complete.

Micro Focus Enterprise Developer UNIX Components Installation Options

Installing into a different location

To install in a different location use the -installlocation="Location" parameter to specify an alternative directory location. For example:

./setup_entdev_8.0_platform -installlocation="full path of new location"



Note: You can use variables when specifying an absolute path for -installlocation. For example, the following examples are equivalent:

```
-installlocation="/home/myid/installdir"
-installlocation="$HOME/installdir"
```

You can see details about which additional parameters can be passed to the install script if you enter the help option.

Configuring the Enterprise Server installation

You can use the following options to configure the Enterprise Server installation: [-ESsysLog="Y/N"] [-ESadminID="User ID"] [-CASrtDir="location"], where:

- **-ESsysLog** Use this to enable ("Y") or disable ("N") Enterprise Server system logging. Logging is enabled by default. Log files are saved in /var/mfcobol/logs.
- -ESadminID Sets the Enterprise Server System Administrator Process User ID from the command line for example, -ESadminID="esadm". The default user ID is the one that runs the installer.
- -CASrtDir Specifies the location were the Enterprise Server run-time system files are placed - for example, -CASrtDir="/home/esuser/casrt/es". The default location is /var/ mfcobol/es.

Installing Silently

You can install Micro Focus products silently by using command line parameters to specify the installation directory, user information, and which features to install. You must execute the command with superuser permissions.

You can use the following command line arguments to install silently on UNIX/Linux. You need to execute the commands as root:

-silent -IacceptEULA

For example, execute:

setup filename -silent -IacceptEULA

After Installing

- See Changes in Behavior or Usage in your product documentation and in the Release Notes for important information about changes in this release that might affect existing applications.
- Check the Product Documentation section of the Micro Focus Customer Support Documentation Web site for any documentation updates.

Configuring Enterprise Developer

If you have used Eclipse from the same workspace before, the Eclipse perspective settings are not reset after installing any Micro Focus product. To pick up any new features, you must reset the perspective you are working with after installation:

- 1. Open the existing workspace with this product.
 - You may receive some warnings or errors which you can ignore.
- 2. Make sure you are in the perspective you need to reset by clicking Window > Perspective > Open Perspective > Other.
- 3. From the Open Perspective dialog box, click the perspective you want to reset.
- 4. Click OK.
- 5. Click Window > Perspective > Reset Perspective.
- 6. When prompted, click Yes.
- Reapply any customizations.

On Windows

Using an X Server on Windows

Some features of Enterprise Developer for Eclipse on Windows require an X Server installation such as Micro Focus Reflection Desktop for X or Micro Focus ViewNow X.

Managing the Microsoft Build Tools and Windows SDK Packages

There are a number of COBOL development features that depend on the Microsoft Build Tools and Windows SDK packages. By default, the product installer downloads and installs these packages to their default locations. The installer then sets your COBOL environment to depend on those downloaded versions.

You can use the Microsoft Build Tools and Windows SDK Packages configuration utility - cblms - to view which versions are in use, and also configure your COBOL environment if you require something other than the standard usage.

There is an option within the product installer to skip the installation of the default packages (skipmstools=1); however, this does skip both packages, so make sure that you do already have the package(s) that you require before setting this - see Microsoft Package Dependencies for details on the package(s) you may require.

The Microsoft Build Tools and Windows SDK Configuration Utility

Use the cblms command line utility to view and set the package versions in effect for your COBOL environment.



Important: If you are updating or clearing package versions, you must run this utility from a command prompt with administrative privileges.

Syntax:

cblms <option>

Parameters:



Note: <option> settings are case insensitive.

<option> can be one of:

-U

Updates the COBOL environment to use the latest versions of the Microsoft Build Tools and SDK packages that are located in the default folders. Any open IDE instance or command prompt must be restarted before these changes take effect.

-U<ms-pkg>

Updates the COBOL environment to use the latest version of the particular package type that is located in the default folder. Any open IDE instance or command prompt must be restarted before these changes take effect.

-U<ms-pkg>:<version>

Updates the COBOL environment to use a specific version of the particular package type that is located in the default folder. Any open IDE instance or command prompt must be restarted before these changes take effect.

-U<ms-pkg>:<path>

Updates the COBOL environment to use the latest version of the particular package type that is located in the (non-default) folder specified. Any open IDE instance or command prompt must be restarted before these changes take effect.

-U<ms-pkg>:<path>?<version>

Updates the COBOL environment to use a specific version of the particular package type that is located in the (non-default) folder specified. Any open IDE instance or command prompt must be restarted before these changes take effect.

-L

Lists all versions of the Microsoft Build Tools and SDK packages that are located in the default folders.

-L<ms-pkg>

Lists all versions of a particular package type that are located in the default folder.

-L<ms-pkg>:<path>

Lists all versions of a particular package type that are located in the (non-default) folder specified.

-Q

Displays the versions currently in use by the COBOL environment.

-Q<ms-pkg>

Displays the version of the selected package type that is currently in use by the COBOL environment.

-R

Clears all version information. (Only use this option when instructed to by Customer Care.)

-H

Displays the available command line options.

Legend:

<ms-pkg> <ms-pkg> can be one of S or SDK for the Microsoft SDK, or B or BT for the Microsoft Build Tools.

<path> is the path in which to locate packages that are not installed to the default location for <path> their package type.

<version> <version> is the package version with which to update when the latest version is not the one required. When specifying version, it must be in the form:

- n.n.n.n for a Windows SDK
- n.n.n for Build Tools
- *n* for list ID the list ID is displayed using cblms -L.

The following example updates the COBOL environment to use version 10.0.17134.0 of the Windows 10 SDK, installed in C:\WinSDK\10.

cblms -USDK:C:\WinSDK\10\10.0.17134.0

Viewing the Product Help

Enterprise Developer is configured to display the product help available online on the Micro Focus Customer Care website: https://www.microfocus.com/en-us/support/documentation/.

You can view the Enterprise Developer product help in one of the following ways:

Choose whether to view the help online or locally

You can configure Eclipse to show the Enterprise Developer help either online or locally:

- 1. In Eclipse, click Window > Preferences > Micro Focus > Help.
- 2. Either disable or enable Use online documentation, depending on whether you want to see the documentation locally or online.

Online help (default)

- Click Help > Micro Focus > Product Documentation.
- Alternatively, press **F1** inside the editor or from a UI part.

This opens a browser with the Enterprise Developer help.



Note: Ensure that you have an up-to-date version of your browser.

Local help

- 1. Configure Eclipse to use local help as detailed above.
- 2. Access the local help in one of the following ways:
 - Click Help > Help Contents to open the Help Viewer, then open the Micro Focus-branded documentation.
 - Alternatively, press F1 inside the editor or after clicking a dialog within the UI.

Repairing on Windows

If any product files, registry settings or shortcuts are accidentally removed at any point, you can perform a repair on the installation to replace them.

To repair your installation:

- 1. From the Control Panel, click Uninstall a program under Programs.
- 2. Right-click your Micro Focus product and select Repair.

Uninstalling

To uninstall the product, you cannot simply delete its files from your hard disk. To uninstall the product:

- 1. Log in with the same user-ID as you used when you installed the product.
- 2. Click Uninstall a program under Programs in Control Panel.
- 3. Select the product and click **Remove** or **Uninstall** as appropriate.

During the uninstall process, only those files added during the installation (to the installation and Samples directories) are removed. If the installation installed the Microsoft Windows 10 SDK or Microsoft Build Tools packages, these are left in place, although the Micro Focus-related registry entries for these packages are removed.

If the product directory has not been removed, delete any unwanted files and subdirectories within it using Windows Explorer.



Note: The installer creates separate installations for Micro Focus Enterprise Developer Micro Focus Analysis Services Integration, and Micro Focus License Administration. Uninstalling only Enterprise Developer does not automatically uninstall the Micro Focus License Administration or any of the prerequisite software.

To completely remove the product you must uninstall the Micro Focus License Administration as well.

You can optionally remove the prerequisite software. For instructions, check the documentation of the respective software vendor.

Some registry entries are not removed by the uninstallation process and you need to manually delete

The following folders might not be removed:

- The Micro Focus Product Name folder in the Start menu you can delete it manually.
- %systemdrive%\Users\Public\Documents\Micro Focus includes the binaries and the log files of the samples which you have built.
- %ProgramData%\Micro Focus includes some data files used by the Micro Focus licensing system.
- %Program Files%\Micro Focus you can delete it manually.

To silently uninstall the product, you need the setup file and you need to execute the following at the command line:

```
start /wait install-file.exe /quiet /uninstall
```

In addition, the following registry entries are not removed. These are created the first time that an Enterprise Server that has been enabled for performance monitoring starts up:

- Micro Focus Server\Performance\Active Servers
- Micro Focus Server\Performance\PerfIniFile

On UNIX

Configuring the Remote System Explorer Support



Note: The following only applies if you are using Micro Focus Enterprise Developer UNIX Components with Enterprise Developer for Eclipse.

The remote development support from the Eclipse IDE relies upon Micro Focus Enterprise Developer UNIX Components running on the UNIX machine and handling all requests from the IDE for building and debugging programs. Micro Focus Enterprise Developer UNIX Components provides a UNIX daemon, the Remote Development Option (RDO) daemon, which initiates the RDO as Eclipse clients connect to it. Whichever environment is used to start the RDO daemon will be inherited for all servers and hence all build and debug sessions.

Configuring the Environment

You may need to configure some aspects of the environment before you start the daemon. This is because when a build or debug session is initiated from one of the Eclipse clients, the environment used will be inherited from whatever was used to start the daemon. A typical example of the kind of environment that might need to be set up would include database locations and settings for SQL access at build/run time.

Starting the Daemon



Important: Before starting the daemon you must have the following on your UNIX machine:

- A version of Perl.
- A version of Java 8 or later.
- The as (assembler) and 1d (linking) programs on the path, as specified by the PATH environment variable.

The daemon can be run with or without parameters. If no parameters are specified, the process relies on the default values in \$COBDIR/remotedev/rdo.cfg.

Use the following syntax to start the daemon (with super-user authority) on the remote host:

\$COBDIR/remotedev/startrdodaemon [<port> <low port>-<high port>]

where:

<port> is the port number that the daemon should use to listen for connections from Eclipse. If no value is given, it will default to the value specified in \$COBDIR/remotedev/rdo.cfg; the default value on installation is 4075.

Example: To start the daemon listening on port 4999:

\$COBDIR/remotedev/startrdodaemon 4999

This command will override the default port in rdo.cfg.

<low port>-<high port> is the range of ports on which the servers (launched by the daemon) should use to communicate with Eclipse on the client machine. If no values are given, the range defaults to that specified in \$COBDIR/remotedev/rdo.cfg; the default range on installation is 10000-10003.

Example: To instruct the daemon (on port 4999) to instantiate servers using a range of ports 4090-4993:

\$COBDIR/remotedev/startrdodaemon 4999 4090-4993

This command will also override the default ports in rdo.cfg.

If the server has an active firewall, it is important that these ports are open in the firewall settings. You can use the configrdo utility to set the default ports in rdo.cfg to ones already open in the firewall. If you are running on Red Hat 7.2 (or later) or CentOS 7.2 (or later), you can also use the utility to open the required ports in the active firewall. See Configuring the firewall for more information.

Stopping the Daemon

To stop the daemon, type the following command with super-user authority:

\$COBDIR/remotedev/stoprdodaemon <port>

Enabling SHIFT-JIS

By default, support for the character encoding for the Japanese language, Shift-JIS, is not available on Ubuntu and on RedHat OS version 8 or later.

You need to generate the Shift JIS locale on your machine to be able to execute Shift-JIS applications on these platforms. You can do this as follows:

- 1. On RedHat 8, ensure that the glibc-locale-source package is installed.
- 2. Execute the following command with superuser rights in order to generate a Shift-JIS locale using the charset:

```
sudo localedef -f SHIFT_JIS -i ja_JP ja_JP.sjis
```

3. Set the COBUTF8 environment variable to the generated Shift-SJIS locale and LANG to a UTF8 locale:

```
export COBUTF8=ja JP.sjis
export LANG=ja_JP.UTF-8
```

4. Run the cobutf8 utility:

```
cobutf8 < command>
```

See your product documentation for more details about cobutf8.

Repairing on UNIX

If a file in the installation of the product becomes corrupt, or is missing, we recommend that you reinstall the product.

Uninstalling



Note: Before you uninstall the product, ensure that the Enterprise Server instances and the Micro Focus Directory Service (MFDS) are stopped.

To uninstall this product:

1. Execute as root the Uninstall EnterpriseDeveloper8.0.sh script in the \$COBDIR/bin directory.



Note: The installer creates separate installations for the product and for Micro Focus License Administration. Uninstalling the product does not automatically uninstall the Micro Focus License Administration or the prerequisite software. To completely remove the product you must uninstall the Micro Focus License Administration as well.

To uninstall Micro Focus License Administration:

1. Execute as root the UninstallMFLicenseServer.sh script in the /var/ microfocuslicensing/bin directory.

The script does not remove some of the files as they contain certain system settings or licenses.

You can optionally remove the prerequisite software. For instructions, check the documentation of the respective software vendor.

Installing Enterprise Developer for Eclipse (UNIX)

Before Installing

Downloading the Product

- 1. Log into the Software Licenses and Downloads (SLD) site at https://sld.microfocus.com/mysoftware/ download/downloadCenter.
- Select your account and click Entitlements.
- 3. Search for the product by using any of the available search parameters.
- Click Show all entitlements.
- 5. Click Get Software in the Action column for the product you want to download or update. In the File Type column, you see entries for "Software" for any GA products, and "Patch" for any patch updates.
- 6. Click Download on the relevant row.

- The "awk", "ed", "ps", "sed", tar", "sed", and "which" utilities must be installed and added to the PATH.
- If SELinux is installed and you plan to use anything other than core COBOL functionality, or plan to use Enterprise Server within an environment with ASLR enabled, the "SELINUX" configuration must be disabled. To do this, set SELINUX=disabled in /etc/selinux/config.

Libraries required by the setup file

The 32-bit libraries listed below are required on both 32-bit and on 64-bit Operating Systems for this product to install and work correctly.

If installing on a 64-bit OS, the 32-bit libraries are not installed by default and must be installed before you start the installation.

- ¹On SUSE 12 or 15, you can only install the 64-bit version of Enterprise Developer. The glibclocale-32bit library is still required by the SafeNet licensing components.
- * Additional libraries required to use the core_on_error runtime variable. The gdb packages (for the GNU Project Debugger) can be installed from the install media for your OS.
- ²The glibc-locale-32bit library is only required if you want to install the SafeNet licensing components. If this is present, the installer installs and configures both SafeNet and AutoPass licensing. If glibc-locale-32bit is not installed, the installer only installs AutoPass licensing.
- ³On 64-bit Red Hat 7, you only need to install glibc-2.17*.x86_64 and glibc-2.17*.i686.
- ⁴On Red Hat, these libraries are required to enable COBOL and PL/I to compile.
- ⁵On Red Hat, only the 64-bit gcc libraries are required.
- ⁶For SUSE 12 and later, you might need to install the Notifications Library tools (libnotify-tools). This is to enable notifications to be displayed by the notify-send tool when starting Enterprise Developer for Eclipse from a desktop icon. Execute the following command to install the libnotifytools library:
 - zypper install libnotify-tools
- ⁷The minimum GTK support required is 3.22. Certain platforms meet this requirement without the need of installing the libraries manually; for example Red Hat 7.4 and SUSE 12 SP3.

**Operating system libraries required for PL/I support on both SUSE and Red Hat.

Visit the Red Hat Web site for more information.

Required environment variables

Before you start the installation, you need to set the environment as follows:

Set the JAVA HOME environment variable. When installing the product, set this variable to a 64-bit Java installation or the installation terminates. For example, execute the following:

```
export JAVA HOME= java install dir
```

where java_install_dir is the path to the JAVA installation directory such as /usr/java/javan.n

Add \$JAVA HOME/bin to your system PATH variable. To do this, execute:

```
export PATH=$JAVA HOME/bin:$PATH
```

You need to set the LANG environment variable to pick up localized messages. If you do not set it as specified here, the installation will run but you might experience unexpected behavior from the installer.

The LANG settings are English and Japanese only so set it to one of the following locales:

```
C, default, en_GB, en_GB.UTF-8, en_US, en_US.UTF-8
ja_JP, ja_JP.SJIS, ja_JP.UTF-8, ja_JP.eucJP, ja_JP.eucjp, ja_JP.sjis,
ja_JP.ujis, ja_JP.utf8, japanese
```

You can set LANG before running the setup file as follows:

```
export LANG=C
```

Alternatively, add it to the start of the setup command line:

```
LANG=C ./setupfilename
```

See Using the LANG Environment Variable for details.

Software installed by the setup file

The setup file installs Enterprise Developer and the 64-bit version of Eclipse 4.20 (2021-06). After the installation, you can install Enterprise Developer as a plug-in into other Eclipse 4.20 (2021-06) instances available on the same machine - see Installing Enterprise Developer into other instances of Eclipse.



Note: On SUSE platforms, you can only use the 64-bit version of Eclipse to produce 64-bit applications; on other 64-bit platforms, you can use Eclipse to produce both 32-bit and 64-bit applications.

Xterm, the terminal emulator for the X Window System, is part of your UNIX/Linux distribution but is not installed by default. Use your UNIX/Linux installation media to install it.

Requirements for running the product

Java 11 (64-bit) is required to run the Eclipse IDE. The minimum recommended version is Adoptium's OpenJDK Temurin 11 (LTS) with HotSpot, which the Windows product installs automatically. You can download Adoptium's OpenJDK Temurin 11 (LTS) with HotSpot from Adoptium's Web site and unpack the archive anywhere on your machine.

License Manager requirements

- For local servers, you do not need to install the Micro Focus License Administration tool separately, as the setup file installs a new Enterprise Developer client and a new licensing server on the same machine.
- If you have any network license servers, you must update them before you update the client machines.

If you are upgrading from Enterprise Developer release 2.2 or earlier, uninstall the license manager before installing the product.

You can download the new version of the license server software by following these steps:

- Log into the Software Licenses and Downloads (SLD) site at https://sld.microfocus.com/mysoftware/ download/downloadCenter.
- 2. Select your account and click **Downloads**.
- 3. Select a product and a product version from your orders.
- 4. In the list of software downloads, locate the License Manager.
- 5. Click **Download** to download an archive with the installers.
- 6. Run the installer suitable for your Operating System to install License Manager on your machine.

Issues with the Installation on UNIX and Linux

Installing on Linux

On Linux, the RPM installer for Enterprise Developer for Eclipse installs a 64-bit version of Java. When you start the installation, if the 32-bit version of Java is already installed on your Linux machine, you might not be able to install Enterprise Developer. This is a known issue with the Oracle Java installers for Linux which prevents you from installing both the 32-bit and the 64-bit versions of Java on the same machine. To work around this problem:

- Download the 64-bit Java distribution in a compressed .tar format from the Oracle Web site.
- Untar the distribution into a location different from the one used for the 32-bit Java version. For example, untar in /usr/local/java64 and not in /usr/local/java.
- Set JAVA_HOME and LD_LIBRARY_PATH to the 64-bit version of Java so that it is used to install and run Enterprise Developer.

Installing on Red Hat 8.x s390

On Red Hat 8.x s390, the RPM non-root install method is not supported due to errors given by cpio. You receive the following messages:

```
error: unpacking of archive failed on file /usr/lib/.build-id/lb/
af99f26c6b4c00ca499a3199a574b73aeb3854;6092b79c: cpio: symlink failed - No
such file or directory
error: Micro_Focus_cobol_server-7.0.0.0-100700.s390x: install failed
```

As a result, the installation in this scenario is incomplete.

Installing while using AFS/Kerberos authentication

If you are using AFS/Kerberos authentication to log onto your Linux system then you need to ensure you have a local user ID which SOA and Enterprise Developer components of the product can use. This user ID must be set up prior to running the installer. When running the installer you need to specify -ESadminID=[User ID] on the command line so it is used by the installer.

License Server

You need to configure the computer hostname to ensure the license server will start properly.

To avoid performance issues, "localhost" and the computer hostname must not both be mapped to IP address 127.0.0.1. You should only map "localhost" to IP address 127.0.0.1.

The following is an example of how to specify these entries correctly in the /etc/hosts file:

```
127.0.0.1 localhost. localdomain localhost
IP machinelonghostname machineshorthostname
```

where IP is the unique IP address of the computer in xx.xx.xx format.

Basic Installation

The instructions in this section apply when you are performing a basic installation of this product for the first time. If you are an administrator, you can perform a basic installation on a local machine before performing a more advanced installation when rolling out the product to developers within your organization.

For considerations when installing this product as an upgrade, for additional installation options or nondefault installations and for installing the mainframe components, see Advanced Installation Tasks in your product Help.

Installing the software

Micro Focus offers two types of installers on UNIX and Linux - a proprietary Micro Focus installer for installing on UNIX and Linux and a standard RPM (RPM Package Manager) installer for installing on Linux. See your product Help for instructions on how to use the RPM installer.

Before starting the installation, see *Software Requirements*.

These are the steps to install this product using the Micro Focus installer:

1. Give execute permissions to the setup file:

```
chmod +x setup_entdev_edeclipse_8.0_platform
```

2. Run the setup file with superuser permissions:

```
./setup_entdev_edeclipse_8.0_platform
```

If you don't run this as superuser, you are prompted to enter the superuser password during the install.

The COBOL environment is installed by default into /opt/microfocus/EnterpriseDeveloper, (COBDIR). A full version of Eclipse, with the Micro Focus plugins already installed, is present in the \$COBDIR/eclipse directory.

To install in a different location use the -installlocation="Location" parameter to specify an alternative directory location. For example:

```
./setup_entdev_edeclipse_8.0_platform -installlocation="full path of new
location"
```



Note: You can use variables when specifying an absolute path for -installlocation. For example, the following examples are equivalent:

```
-installlocation="/home/myid/installdir"
```

```
-installlocation="$HOME/installdir"
```

You can see details about which additional parameters can be passed to the install script if you enter the -help option.



Note: See Installing in an Ubuntu Docker Image Running on Windows 11 for specific installation instructions for this scenario.

SafeNet Sentinel considerations

- The installation of this product could affect the SafeNet Sentinel licensed components running on your machine. During installation licensing is shutdown to allow files to be updated. To ensure the processes running on your machine are not affected, you need to use the -skipsafenet option, which skips the installation of SafeNet:
 - . /setup_entdev_edeclipse_8.0_platform -skipsafenet
- To protect the SafeNet Sentinel installation from accidental updating you can create an empty file named SKIP_SAFENET_INSTALL in /var/microfocuslicensing/ as follows:

```
touch /var/microfocuslicensing/SKIP SAFENET INSTALL
```

While the file is present, the SafeNet installer does not make changes to the installation or shutdown the running license daemons. If licensing needs to be updated later, you can rerun the MFLicenseServerInstall.sh from within the \$COBDIR/safenet folder with the force command line option:

```
cd $COBDIR/safenet
./MFLicenseServerInstall.sh force
```

AutoPass Licensing considerations

The installation of this product could affect the AutoPass licensed components running on your machine. During installation, the licensing shuts down to allow files to be updated. To ensure the processes running on your machine are not affected, you need to use the -skipautopass option, which skips the installation of AutoPass:

```
./setup file -skipautopass
```

To protect the AutoPass installation from accidental updating, you can create an empty file named SKIP_AUTOPASS_INSTALL in /opt/microfocus/licensing as follows:

```
touch /opt/microfocus/licensing/SKIP AUTOPASS INSTALL
```

While the file is present, the AutoPass installer does not make changes to the installation or shutdown the running license daemons. If licensing needs to be updated later, you can rerun the MFLicenseServerInstall.sh from within the \$COBDIR/safenet folder with the force command line option:

```
cd $COBDIR/safenet
./MFLicenseServerInstall.sh force
```

Setting up the environment

If you have installed the product to a directory other than the default one, you need to set the environment as described below.



Note: The default directory is /opt/microfocus/EnterpriseDeveloper.

1. To set up your product, execute:

```
. cobsetenv
```

2. To verify that your product is installed, execute:

cob -V



Important: These commands set the environment only for the current shell. You need to execute them for each new shell that you start.

To avoid having to run cobsetenv for every shell, add these commands to the shell initialization files (such as /etc/profile, /etc/bashrc).

Note that cobsetenv is only compatible with POSIX-like shells, such as bash, ksh, or XPG4 sh. It is not compatible with C-shell or pre-XPG4 Bourne shell.

Starting the product

To start Eclipse:

If you are using a GUI interface, double-click the product icon (automatically installed on your desktop).



Note: The installer automatically creates a shortcut icon for the product on the desktop for the user for which you ran the install script. If you need to create desktop icons for other users' desktops on the same machine, or if the icon was not created on the desktop for the root user, run the following shell script as the user you need to login as: \$COBDIR/bin/createdesktopicon.sh

• If you are using a non-GUI interface, such as a terminal emulator, type the following from a command prompt:

eclipse

Advanced Installation Tasks

Installing in an Ubuntu WSL2 on Windows

The following instructions apply when you install the product inside Ubuntu 20.04 WSL2 on Windows.



Note: The embedded **Rumba Mainframe Display** view is not supported in this scenario. You can use the HACloud TN3270 Session Server which is available with the product instead. See *Terminal Emulation with Micro Focus Host Access for the Cloud*.

Prerequisites

You need to have a new instance of a Ubuntu 20.04 WSL2 running on Windows.

- 1. In Windows, open the Ubuntu WSL2 console.
- 2. Download and install Java. Eclipse supports versions 11 through to 15.
- **3.** Create a symbolic link in Ubuntu from <code>java-install-dir/bin/java</code> to <code>/usr/bin/java</code>.

This enables the installer to locate Java when you run commands as the root user.

4. Execute the following commands to install the prerequisites for Enterprise Developer:

```
sudo apt-get update
sudo apt-get install libgc1c2
sudo apt-get install libgtk-3-0
sudo apt-get install libnotify-bin
sudo apt-get install unzip
sudo apt-get install xterm
sudo apt-get install nasm
sudo apt-get install gcc
```

Installing the product

- To install the product, execute:
 - sudo ./setup_enterprisedeveloper_deveclipse_8.0_ubuntu_x64
- Follow the rest of the instructions in these Install Notes to license the product, and to set the
 environment.

Known issues in Ubuntu running on Windows 11

- The Eclipse icon in the Windows Start menu does not work.
- If you reset Ubuntu 20.04 WSL2, the Micro Focus icons created in Ubuntu are not removed from the Start menu.

Installing as an upgrade

This release works concurrently with the previous version of Enterprise Developer, so you do not need to uninstall it.

Install the latest version in a different location and set the environment to point to it. To do this, run the Enterprise Developer installer with the –installlocation option:

1. Execute the following command:

```
. /InstallFile -installlocation="/opt/microfocus/EnterpriseDeveloper"
```



Note: You can use variables when specifying an absolute path for -installlocation. For example, the following examples are equivalent:

```
-installlocation="/home/myid/installdir"
```

```
-installlocation="$HOME/installdir"
```

2. Execute cobsetenv to set the environment and point to the new install location:

```
. cobsetenv
```



Note: cobsetenv is only compatible with POSIX-like shells, such as bash, ksh, or XPG4 sh. It is not compatible with C-shell or pre-XPG4 Bourne shell.

Preserving the MFDS and Enterprise Server region configuration

The following information applies when you are upgrading from releases 6.0 or 7.0.

If you install this release to the same install location as release 6.0 or 7.0, the product in the current location is moved to a backup directory name.

For example, if the 7.0 product is installed in the default install location, /opt/microfocus/ EnterpriseDeveloper, during the upgrade it is moved to /opt/microfocus/ EnterpriseDeveloper.BKP.YYYY-MM-DD.HH:MM:SS. The new release will be installed in /opt/ microfocus/EnterpriseDeveloper.

Note that your original installation might include some files that you changed or added to, and you need those changes preserved in the new installation.

During the upgrade, the installer moves a number of changed files to a different configuration location and symbolically links them back into the new release install location. The configuration location is one of the following:

- The default config location is /opt/microfocus/config/.
- For non-root installation, the default location is \$HOME/microfocus/config/.
- To specify your own configuration location, run the setup file with the following command-line option: mfconfiglocation=[location]

The setup file creates a directory in the configuration location using the sum of the value of the \$COBDIR path. This is so that each configuration area is unique to each product installation. The configuration files and directories are then placed in this COBDIR hash-numbered directory. In the examples below, the install location generates a hash of 12345.

The file /opt/microfocus/config/12345/COBDIRlocation.txt details the COBDIR the configuration area is associated with.

Currently, the setup file only moves the following files and directories:

Source	Destination
secrets	/opt/microfocus/config/12345/secrets/
commonwebadmin.json	<pre>/opt/microfocus/config/12345/escwa/ commonwebadmin.json</pre>
mfdsacfg.xml	<pre>/opt/microfocus/config/12345/mfds/ mfdsacfg.xml</pre>
mfds	<pre>/opt/microfocus/config/12345/mfds/ mfds/</pre>

If you have changed any other files in the original installation, you need to be copy these manually from the backup directory, /opt/microfocus/EnterpriseDeveloper.BKP.YYYY-MM-DD.HH:MM:SS, into the install location after the upgrade installation is complete.

Installation Options

Installing into a different location

To install in a different location use the -installlocation="Location" parameter to specify an alternative directory location. For example:

./setup_entdev_edeclipse_8.0_platform -installlocation="full path of new location"



Note: You can use variables when specifying an absolute path for -installlocation. For example, the following examples are equivalent:

```
-installlocation="/home/myid/installdir"
-installlocation="$HOME/installdir"
```

You can see details about which additional parameters can be passed to the install script if you enter the help option.

Configuring Enterprise Server

You can use the following options to configure the Enterprise Server installation: [-ESsysLog="Y/N"] [-ESadminID="User ID"] [-CASrtDir="location"], where:

- **-ESsysLog** Use this to enable ("Y") or disable ("N") Enterprise Server system logging. Logging is enabled by default. Log files are saved in /var/mfcobol/logs.
- -ESadminID Sets the Enterprise Server System Administrator Process User ID from the command line for example, -ESadminID="esadm". The default user ID is the one that runs the installer.
- -CASrtDir Specifies the location were the Enterprise Server run-time system files are placed - for example, -CASrtDir="/home/esuser/casrt/es". The default location is /var/ mfcobol/es.

Installing Silently

You can install Micro Focus products silently by using command line parameters to specify the installation directory, user information, and which features to install. You must execute the command with superuser permissions.

You can use the following command line arguments to install silently on UNIX/Linux. You need to execute the commands as root:

```
-silent -IacceptEULA
```

After Installing

- See Changes in Behavior or Usage in your product documentation and in the Release Notes for important information about changes in this release that might affect existing applications.
- Check the Product Documentation section of the Micro Focus Customer Support Documentation Web site for any documentation updates.

Configuring Enterprise Developer

If you have used Eclipse from the same workspace before, the Eclipse perspective settings are not reset after installing any Micro Focus product. To pick up any new features, you must reset the perspective you are working with after installation:

- 1. Open the existing workspace with this product.
 - You may receive some warnings or errors which you can ignore.
- 2. Make sure you are in the perspective you need to reset by clicking Window > Perspective > Open Perspective > Other.
- 3. From the Open Perspective dialog box, click the perspective you want to reset.
- 4. Click OK.
- 5. Click Window > Perspective > Reset Perspective.
- When prompted, click Yes.
- 7. Reapply any customizations.

Configuring the Environment for Developing RDBMS Applications on **UNIX**



Note:

- If you are working with remote projects, you need to configure the environment before you start the remote server process.
- On UNIX, if you are working with local projects, you need to configure the environment before you start Eclipse.
- Ensure the COBOL and the third-party software environments are set.
- 2. Set up the RDBMS environment.
 - Refer to your RDBMS vendor documentation for details.
- 3. Set COBCPY as required in order for the IDE to locate any copybooks that are external to your project.
- 4. If working with Pro*COBOL/Cobsql applications you need to set COBOPT. This sets the appropriate linker options for the platform and the COBOL working mode:

To do this, execute the following at the command line:

```
$COBDIR/src/oracle/set_cobopt_oracle
COBOPT=$PWD/cobopt.ora
export COBOPT
```

Enabling SHIFT-JIS

By default, support for the character encoding for the Japanese language, Shift-JIS, is not available on Ubuntu and on RedHat OS version 8 or later.

You need to generate the Shift JIS locale on your machine to be able to execute Shift-JIS applications on these platforms. You can do this as follows:

- 1. On RedHat 8, ensure that the glibc-locale-source package is installed.
- 2. Execute the following command with superuser rights in order to generate a Shift-JIS locale using the charset:

```
sudo localedef -f SHIFT_JIS -i ja_JP ja_JP.sjis
```

3. Set the COBUTF8 environment variable to the generated Shift-SJIS locale and LANG to a UTF8 locale:

```
export COBUTF8=ja JP.sjis
export LANG=ja_JP.UTF-8
```

4. Run the cobutf8 utility:

```
cobutf8 < command>
```

See your product documentation for more details about cobutf8.

 - Alternatively, press F1 inside the editor or after clicking a dialog within the UI.

Repairing

If a file in the installation of the product becomes corrupt, or is missing, we recommend that you reinstall the product.

Uninstalling



Note: Before you uninstall the product, ensure that the Enterprise Server instances and the Micro Focus Directory Service (MFDS) are stopped.

To uninstall this product:

1. Execute as root the Uninstall_EnterpriseDeveloper8.0.sh script in the \$COBDIR/bin directory.



Note: The installer creates separate installations for the product and for Micro Focus License Administration. Uninstalling the product does not automatically uninstall the Micro Focus License Administration or the prerequisite software. To completely remove the product you must uninstall the Micro Focus License Administration as well.

To uninstall Micro Focus License Administration:

1. Execute as root the UnInstallMFLicenseServer.sh script in the /var/ microfocuslicensing/bin directory.

The script does not remove some of the files as they contain certain system settings or licenses.

You can optionally remove the prerequisite software. For instructions, check the documentation of the respective software vendor.

- If you have purchased licenses for a previous release of this product, those licenses will also enable you to use this release.

Log on as root, and from a command prompt type:

/var/microfocuslicensing/bin/cesadmintool.sh

Installing licenses

You need either a license file (with a .mflic extension for Sentinel RMS licenses or an .xml extension for AutoPass licenses) or an authorization code which consists of a string of 16 alphanumeric characters (Sentinel RMS licenses only). You need to install AutoPass licenses into the existing Micro Focus License Administration tool, and not in the AutoPass License Server.

If you have a license file

Windows: To use the GUI Micro Focus License Administration

 - · Click Browse next to the License file field and select the license file (which has an extension of .mflic or .xml).

If you have an authorization code



Note: Authorization codes are only available with Sentinel RMS licensing.

Authorizing your product when you have an Internet connection



Note:

- This topic only applies if you have an authorization code. Authorization codes are only available with Sentinel RMS licensing.
- It is not possible to install licenses remotely. You must be logged into the machine on which you are installing the licenses.

The following procedure describes how to authorize your product using a local or network license server. The license server is set up automatically when you first install the product.

Windows: To use the GUI Micro Focus License Administration

- 1. Start Micro Focus License Administration.
- 2. Click the **Install** tab.
- 3. Type the authorization code in the Enter authorization code field.
- 4. Click Authorize.

If you change the name of the machine running your license server after it has granted licenses, the licenses stop working.

Windows: To use the command-line Micro Focus License Administration tool
