- Microsoft Windows Server 2012 R2
- Microsoft Windows Server 2016
- Microsoft Windows 7 SP1
- Microsoft Windows 8
- Microsoft Windows 8.1
- Microsoft Windows 10



Important: Update for Universal C Runtime in Windows is required for all Microsoft Windows operating systems. For Microsoft Windows Server 2016, the installation option Windows Server (Server with Desktop Experience) is required.

What's New in Silk Meter 19.5

Details the enhancements and changes introduced with Silk Meter 19.5.

Third-Party Updates

The following third-party updates were made for Silk Meter 19.5 to resolve vulnerability issues:

- Updated Oracle Java Runtime to Azul Zulu 32-bit runtime (zulu8.31.0.1-jdk8.0.181-win_i686).
- Updated Xerces XML Parser to version 3.2.2.
- Updated OpenSSL to version 1.1.0i.

Known Issues

Lists the known issues with Silk Meter 19.5.

Silk Meter clients cannot find the license server when performing license checks

This is possibly a DNS issue. The Silk Meter client and the Silk Meter server must know the name of each other. If the Silk Meter server name is not provided by a DNS service, add the name and the IP address of the Silk Meter server to the files on the Silk Meter client.

The Silk Meter server does not work correctly when switching between standalone and server mode

Only use the standalone mode when no other machine uses the computer as a license server. If configured for standalone mode, the local Silk Meter Manager should be stopped by using the **Service Manager**. If the Silk Meter Manager is not stopped while running in standalone mode, remote computers can perform setting changes that override the local settings.

The standalone mode does not support host ID bound licenses for Java clients

This is a limitation for Silk Meter and there is no workaround.

If User Account Control (UAC) is turned on, the Policy Administrator cannot successfully check in/out mobile licenses from a Silk Meter server

Start the **Policy Administrator** in elevated mode.

The Silk Meter server does not notice new licenses installed through the standalone license installer

When this issue occurs, these new licenses, including mobile licenses, are lost if additional licenses are imported through the **Policy Administrator**. To avoid this issue, restart the Silk Meter Proxy Service after importing standalone licenses by using the standalone license installer.
